It maintains flexibility to allocate up to 35% in other equities. The fund targets high growth potential while acknowledging the increased volatility and liquidity risks inherent in small caps. Best suited for investors with above 5 years investment horizon and high-risk tolerance.

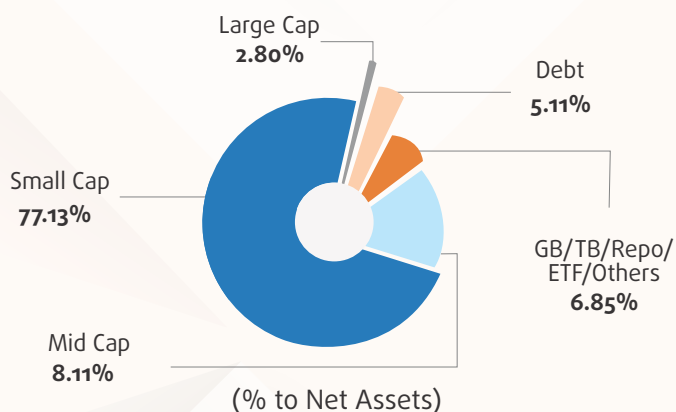

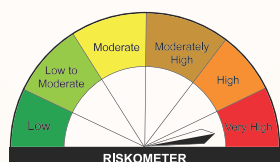

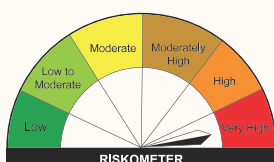
